Applicant hereby agrees to abide by the following terms and conditions in the distribution of the Tickets for Arooga's Grille House & Sports Bar Holdings, LP ("Arooga's") in the Funds for Friends Program:

(1). **Charitable Purpose.** Applicant hereby certifies that its fundraising activities are for a permissible non-profit purpose as defined by Section 501 of the Internal Revenue Code.

(2). **Sales and Payment.** The Applicant shall receive the sum of Fifteen Percent (15%) of the gross sales on the Event Date for any Arooga's customer who presents a Ticket upon payment of their bill, excepting any:

- a. Sums paid to Arooga's for any specials or discounted menu items purchased by a customer presenting a Ticket;
- b. Any tips or gratuity collected by Arooga's from the customer presenting a Ticket; and,
- c. Any sales or other taxes collected by Arooga's from the customer presenting a Ticket.

Payment along with an accounting shall be mailed by Arooga's to Applicant on or before the thirtieth (30th) day after the Event Date.

(3). **Coupon Voucher Distribution & Redemption:**

a. The Applicant will be responsible for the printing and distribution of all tickets. You are also responsible for making sure all of your guests hand in the coupon voucher to your server. This is the only way of tracking the success of your fundraiser and we will only reward receipts with vouchers attached.

b. All coupon vouchers printed by the Applicant must be distributed prior to the Event Date.

c. The Applicant understands that Arooga's benefits from the Fund for Friends fundraising through the assistance of the Applicant in soliciting customers to dine at Arooga's locations. As such no tickets may be distributed prior to or during the event at or around any Arooga's or Brew 22 location, including within or around the restaurant or the parking lots outside of any location. Including any other remedy set forth herein, Arooga's reserves the right to confiscate and dishonor all Tickets distributed by the applicant.

(4). Covered Locations & times. The coupon vouchers unless otherwise specified shall be honored at the following locations: All Arooga's Grille House & Sports Bar locations. The coupon voucher are valid all day long during regular business hours of each location. Call 635-9464 for Arooga's address information. Arooga's hours Monday & Tuesday 11am-2am.

(5). No Joint Venture. Applicant and Arooga's are separate and independent entities. This Application and Agreement shall not be construed or interpreted as a partnership or joint venture agreement. Each party hereby agrees to indemnify, defend and hold harmless the other party, for the negligent acts and/or omissions of its own members, volunteers, employees, agents, contractors and representatives.

(6). Notice. Applicant hereby represents and warrants that it will disclose the applicable terms of this Application and Agreement to its members, volunteers, employees, agents, contractors and representatives to ensure their compliance with these conditions.

(7). Default. If Applicant breaches any of the terms and conditions of this Application and Agreement, Arooga's reserves the right to retain all sums owing to Applicant and/or temporarily or permanently suspending Applicant's permission to participate in the Funds for Friends program.
